## ELECTION RESULTS FOR THE TWO NUNAVIK HEALTH CENTRES

Members of the boards of directors of the Ungava Tulattavik and Inuulitsivik Health Centres by the inhabitants of the northern villages and election of four persons from among those exercising their profession at the health centres

**Kuujuuaq, November 20** – The Nunavik Regional Board of Health and Social Services (NRBHSS) would like to announce the election results for the boards of directors of the Ungava Tulattavik and Inuulitsivik Health Centres for a three-year term.

### Ungava Tulattavik Health Centre
